In that case, Super Sires contract will take precedence. b. If a breeding does not sell by May 31 of breeding year, stallion owner shall be required to pay a \$500 "No Sale Fee" to Super Sires, LLC. A "No Sale Fee" will not be charged to Deceased stallions that DO NOT sell in auction.

WITNESSETH:

In accordance of Super Sires bylaws, and in addition to required fees for annual purchase of a Super Sires stallion contract, we the owner/agent of stallion listed above, transfer and assign to Super Sires Inc, a Breeding Service for above named year to above named stallion. All parties are in agreement that breeding service is assignable only by Super Sires Inc, pursuant to terms and conditions of Super Sires Stallion Service Auction Contract. Said terms and conditions are incorporated herein by direct reference thereto. All parties in this agreement are further bound and agree to all of the following terms and conditions:

- Contracted mare owner shall receive one (1) breeding to produce one (1) viable, live foal in contracted breeding year as noted above.
- In the event contracted mare does not produce a live and viable foal that stands and nurses, mare owner will be entitled to one (1) rebreed following year pursuant to this contract. In the event of death or vet-certified breeding unsoundness of said mare, a substitute mare approved by stallion owner/agent may be bred.
- In the event that above named stallion dies or becomes unfit for breeding purposes, breeding fees paid by mare owner to Super Sires Inc shall be refunded.
- A Breeder's Certificate shall be furnished to mare owner by stallion owner/agent when stallion owner/breeding farm fees are fulfilled in accordance with stallion owner/agent contract.
- Breeding will sell under conditions as set forth in Super Sires Stallion Service Auction Contract completed by stallion owner/agent, which is outlined below in #6. Super Sires Inc acts only as agent in this sale and will not be responsible for accident, sickness, or death to any stallion, mare and/or foal. Stallion owner/agent and mare owner hold Super Sires Inc harmless in the event of a published error of these fees.
- Mare owner's payment to Super Sires Inc is proof of acceptance to terms and conditions of this agreement.
- Upon sale of stallion breeding, stallion owner/agent and mare owner will each receive a copy of Super Sires Stallion Service Auction Contract from Super Sires Inc.
