All risk mortality and theft coverage reimburses you for the death, theft, or human destruction of your covered horse, including illness or disease.

An insurance policy must be purchased online or through a Markel representative to extend coverage after the 24-hour period. Online sale to be held November 10-21, 2023. Sale will open at 4:00 pm CST / 5:00pm EST on November 10, 2023 and will begin the soft close at 4:00pm CST / 5:00pm EST on November 21, 2023.

*Embryos/unborn foals are not eligible.

How do I extend mortality insurance coverage on my newly purchased horse(s), or add my new horse to already existing Markel® policy?

Markel’s fall of the hammer mortality insurance coverage will cease 24-hours after the end of the Super Sires Future Stars Online Sale. Auction starts closing at 3:55 pm central time November 21, 2023. Sale will close at 4 pm central time or when all bidding stops on any lot.
